Purpose:

The Lawrence East Partnership Program (LEPP) is a comprehensive and collaborative support service for residents who are vulnerable and have complex needs living in two Toronto Community Housing buildings, 4175 and 4205 Lawrence Avenue East in Scarborough.

As part of the LEPP team, the Independent Support Worker will engage residents and support them with skill building to ensure they maintain their independence. In addition to skill building, the Independent Support Worker will accompany residents in the local area and work with them in their homes to support their skill development

Key areas of responsibility:

- Assess clients as scheduled or whenever necessary
- Teach and model life skills and activities of daily living for clients
- Accompany clients within the community to support skill building
- Report and record changes on client health status (physical/mental) on a daily basis, particularly that
 of significant concerns
- Collaborate with team to provide holistic support to clients
- Update client care plan based on client's needs and assessment
- Utilize electronic medical record (PSS) to update, monitor clients
- Participate at team events/programming as needed
- Participate in organizational committees and appropriate community committees
- Perform other duties as assigned that are reasonable within the scope of the job

Preferred Qualifications (Knowledge, Experience):

- Knowledge of and ability to support clients living with complex challenges
- Ability to work independently and function as a team member contributing to the growth of the team
- Ability to multi-task when delegated

- · Strong communication, verbal, listening and writing skills
- Flexibility and ability to work all shifts and between multiple sites as necessary (including evenings and Saturdays)
- Good assessment and critical thinking skills
- Knowledge of basic computer and keyboarding
- Oral and/or written fluency in other languages relevant to the community the program serves is a
 definite asset
- Two years of experience working with vulnerable populations including those living with mental health and addiction challenges (asset)

Essential Competencies (Skills and Attributes):

- Sensitivity to and awareness of cultural, racial and socio-economic diversity within the community particularly around mental health and addiction challenges
- Knowledge and understanding of low income and/or vulnerable populations in the West Hill/KGO community and complex needs of residents preferred
- Effective skills in conflict resolution, mediation and crisis management
- Strong communication, verbal, listening and writing skills
- Proficiency in the use of computers and various software applications
- Proficiency reading and writing a second language is an asset

- Comfortable working alone in the community with minimal supervision
- Working in Toronto Community Housing buildings outside regular office hours
- Working environment may include common spaces or residents homes which may not be smokefree, may have pets or pests
- Travel between two sites will be required for this position (1 block apart)
